

# Create Change with New Life

The Drug Addiction Treatment Act of 2000 (DATA 2000), has established a new paradigm for the medication-assisted treatment of opioid addiction in the United States. The use of opioid medications to treat opioid addiction is permissible by qualified physicians in treatment settings outside of Opioid Treatment Programs (OTPs) (i.e., methadone clinics). Qualifying physicians may prescribe and/or dispense Schedule III, IV, and V opioid medications for the treatment of opioid addiction if such medications have been specifically approved by the Food and Drug Administration (FDA) for that indication. In addition, DATA 2000 reduces the regulatory burden on physicians practicing opioid addiction therapy by allowing qualified physicians to obtain waivers of the special registration requirements as defined in the Controlled Substances Act.

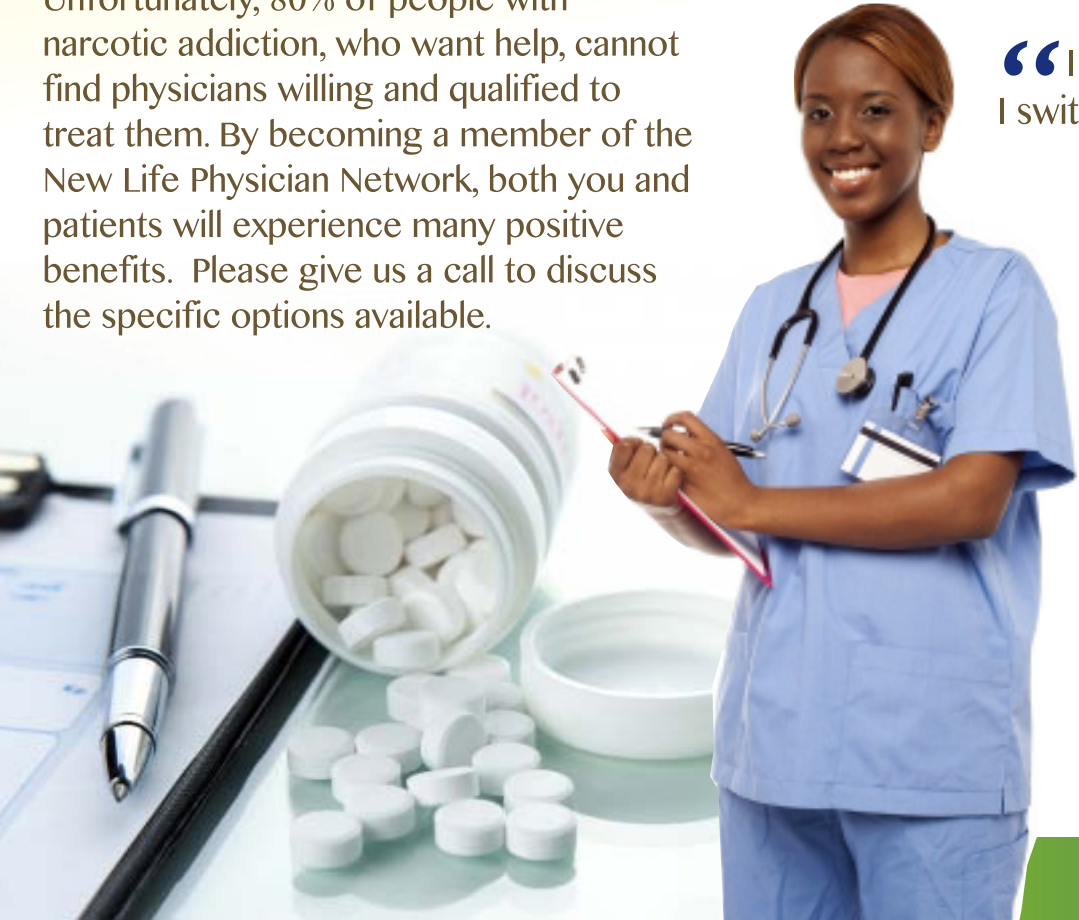
